Trip Commitment & Rule Agreement Form

By signing this form I realize that I am committing my *son, daughter or myself* to participating in the Comet Marching Band's *Walt Disney World Trip* scheduled for **November 6-12, 2019**. I accept the following:

1. My son or daughter will abide by the rules as set forth in "***The Fine Print.***"
2. If I discover too late that my son or daughter is not able to participate in the ***Disney World Trip***, some or all of the money submitted will **NOT** be refunded.
3. I will be responsible for the actions of my son or daughter pertaining to any damages incurred, and if necessary, the cost of a return air flight from Orlando.
4. Neither the Hanover-Horton Schools, HH Bands, nor Chaperones or director are responsible for items left, lost, or stolen throughout the duration of the trip.
5. If my son or daughter is not able to participate, any fund raising money they have earned through school sponsored activities will be placed into the band general fund.
6. I realize that I am entering into a contract with ***Educational Tours Incorporated***, and neither the Hanover-Horton Schools, nor the Director of Bands are liable for any financial issues as a result of this contract.
7. My son or daughter may watch movies rated PG-13 (or cleaner) with no nudity while riding on the bus.
8. I understand the deadlines for refunds if my son or daughter is not able to go.

“The Fine Print”

All students and chaperones who wish to participate in the Comet Marching Band trip to *Walt Disney World* from **November 6-12, 2019**, must be willing to adhere to the following rules. If neither the student nor parent are willing to follow these rules, they should **NOT** commit to go. These rules will be amended as needed, with adequate notice going to all.

The Rules:

1. All students must ride the motor coach to and from Orlando. Students may be allowed to return with parents if they are signed out on the last day of the trip.
2. **All** Students are expected to abide by all school rules as though they were in school.
3. **All** chaperones attending will be expected to abide by all schools rules as though they were students. (This includes a ban on the drinking of **ANY** alcoholic substances for the duration of the trip. Smoking is not permitted in the presence of students.)
4. While at the hotel, students are expected to abide by a “lock-down” time to be decided by the chaperones and the director of bands. (Lock-down: Students must remain in their assigned hotel rooms and keep the noise level down.)
5. Students are to control themselves so as not to disturb other guests of the hotel.
6. Male and female students are not to enter each other’s rooms. Students may fraternize in any public place around the hotel. (i.e.: swimming pools, park benches, hotel lobbies, etc.)
7. Students are not to venture outside the hotel grounds unless accompanied by a chaperone.
8. Any damage done to either the hotel room, the bus, or any attractions will be billed to the student’s parent/guardian.
9. Students who are in possession of illegal substances or weapons, or caught “in flagrante delicto,” will be immediately sent home on an airplane, with the costs absorbed by the parent/guardian.
10. All students who are attending this trip must be participating in the Comet Marching Band.

Penalties for Infractions:

1. Referrals will be issued for the offenses as they are warranted.
2. The chaperones and the director of bands reserve the right to re-assign any student to another room if that student is in violation of **any** of the above rules.
3. If an offense is deemed severe enough, the chaperones and the director of bands may impose a “shadow chaperone” to a student who is unable to control himself or herself.
4. In the worst case, a student will be sent home on an airplane **WITH THE COSTS FOR THE FLIGHT ABSORBED BY THE PARENT/GUARDIAN.**
