Band Students and Parents,

The time has come to push ahead with our plans for taking the Comet Marching Band to Walt Disney World. Attached you will find several things: 2 Pages of Payment Coupons, Travel Protection Insurance, and The Fine Print/Trip Commitment form.

COUPONS:

1. Please use the coupons with each payment.
2. Please list everyone who is going and how the funds are to be disbursed.
3. We will return the coupons to you as a receipt of your payment once it has been deposited.
Please try to keep them just in case they are needed if an error occurs!
4. Only one check per family per payment is needed.

NOTE: Start the coupons on the bottom of the second page and work your way backwards!! (Notice the dates on each)

TRAVEL PROTECTION INSURANCE:

This insurance is an *optional* purchase. It is purchased from *Educational Tours, Incorporated* directly, and would not involve the Hanover-Horton Schools in any way. The cost of this insurance for our trip is **\$61.50**. It would be used if you found out that you could not attend the trip after the deadline for refunds had passed. You could purchase this insurance at any time, **BUT IT MUST BE PURCHASED BY SEPTEMBER 15, 2019!**

NOTE: Very few have ever purchased this insurance in the 20 years that our bands have traveled. However, it is available if you feel you need it.


THE FINE PRINT AND TRIP COMMITMENT FORM:

This is labeled "The Fine Print" because you are always warned not to sign anything without reading "The Fine Print!" It outlines the rules that Chaperones and Students are expected to abide by while on the trip.

NOTE: This form must be signed and included with your first payment before your payment will be deposited!!

ONE FINAL THOUGHT: For the Jazz Band's New York City trip in April of 2018, we were limited by only taking one bus. For this trip we are planning on taking 2 buses, and have plenty of room for any parents or siblings who are willing to commit to the rules of the Fine Print. If our numbers are below 71 participants, the cost will go up considerably. If that is the case, I will have to consider cancelling the trip. Having traveled to Disney World frequently, I can safely say that it would be very difficult to do all that we are doing on our tour for this price if you planned it out on your own. That being said, life will go on if we aren't able to travel next November...
